Hockey Ops Report: Recreation

22 Teams Total

U18 increased by one at tier 2

Monthly goaltending clinics

- > U9 U13, some U15
- 13 participants was the average
- > Families liked the extra session and location
- > Ended after December this year due to a lack of volunteers for the clinic
- > After December it was getting difficult for commitment with increase in games and tournaments

Earlier "Power Skating" sessions were implemented earlier this year

- > Age levels U9 and U11 would prefer more at the beginning of the year.
- As a pilot, U13 and U15 had one high impact power skating session with a different instructor which was well received. The focus was more on speed, power vs. the basics which is what's looked for a U9 and U11. The feedback was very positive as it catered more to the older players.















Hockey Ops Report: Recreation

Pathways

> U13 and U15 pathways was introduced this season straining our ice allotment.

Sort outs

- ➤ No dedicated tier 1 tryouts to keep in line with other associations
- > Sort out format tweaked this year which reduced the amount of ice needed and time at the rink
- > Overall format were skills, then two balancing games
- > Having the evaluations of all players in a level allowed for a simpler team creating exercise with the evaluation data (top players for Tier 1, mid for Tier 2...etc)

Notes of interest

- The single colour sort-out jersey's were logistically more difficult to manage having to collect and re-issue. For 25-26 reversible jerseys will be purchased
- > Volunteer participation burnout, same people all the time, very challenging , many last minute no shows
- > U11 switched from 2 Tier 2 to 2 Tier 3. The results were a more competitive and positive experience for the players.















Hockey Ops Report: Recreation

- Continues balanced team approach for the 24-25 season had positive results. U13/U11 (2014 2013) remains behind development wise due to COVID years.
- Overall most teams were competitive.
- U13 goalie shortage this year, with 1 player at each tier playing goalie all year.
- * Hockey ops will take lessons learned moving forward and continue to make decisions in the best interest of the WCMHA.
- Goalie shortage at U13/U15/U18 may be present next season

House Recommendations

- Goalie clinics
 - Limit these sessions to house for development purposes
 - Start the sessions earlier to get conditioning and interest; August and easier to schedule
- Power skating
 - Implement more high impact skating for U13–U18
 - Schedule the two early in the season
- > Add tier 2 level to the Warriors tournament
- > Evaluate pathway and sort outs use of volunteers vs. paid help
- Continued focus on team declarations next season ensure proper placement of teams

Risk and Safety - Discipline



Summary:

- The Risk & Safety department was lead by VP1 Josh Batley and Risk and Safety Director Kris Hodgins.
- No incidents of spectator ejections in WCMHA and HEO this season.
- Largest offences continue to be: Unsportsmanlike Conduct, Abuse of Officials, Disrespectful, Abusive & Harassing Behaviour, and Discriminatory Slurs.
 - 3 on ice suspensions reviewed and overturned in our favour

WCMHA Internal Investigations:

- A coach suspension (1 game) for conduct that is in violation of our code of conduct towards players
- Multiple player suspensions (one team) due to arena dressing room vandalism zero tolerance
- Warning regarding alcohol use on arena property strictly prohibited
- Concussion protocols were followed and players returned to ice as per Rowans' Law

We all play a part in fostering good sportsmanship - be it as executive, bench staff, players or spectators. Please ensure you do your part to ensure that hockey is a safe and inclusive environment for all.

- Ice request has been made to both the City and Sensplex to obtain same or more allocation for next season.
















Elections for Board of Directors



- "Voting Members:
 - One vote per registered Player in Good Standing, to be given to a Player Representative in Good Standing if the player is under 18 years of age. Team Staff, as registered with HEO Minor, shall also be a Member of the Association and shall be entitled to a vote unless already so entitled as a Player Representative. Special Membership may be granted by the Executive to persons who have demonstrated involvement and interest in the activities of the Association and shall be entitled to a vote unless already so entitled as a Player Representative"
- "Associate Members:
 Individuals not resident within the WCMHA boundaries who have been properly transferred or waived in accordance with HEO Minor and Hockey Canada, shall become Associate Members of the WCMHA upon registration and payment of fees. Associate Members shall be Voting Members of the WCMHA"
















Election Process

Successful candidates will be welcomed to the board and unsuccessful candidates will be thanked for their interest and application.










